Distributions may consist of net income, dividends, and/or net realized capital gains and are taxable in the hands of the investor. Monthly distributions are based on record date on the second Thursday of the month, payable on the second Friday of the month. The final distribution in respect of each taxation year is paid or payable by December 15th of each year or at such other times as may be determined by the fund's manager. The 2018 distributions do not include the December 2018 distribution. Distributions are automatically reinvested unless an investor elects to receive them in cash (excluding the Series T6, FT6, FCT6 and 06). If distributions paid by the fund are greater than the performance of the fund, distributions paid may include a return of capital and an investor's original investment will decrease. A return of capital is not taxable to the investor, but will generally reduce the adjusted cost base of the units held for tax purposes. If the adjusted cost base falls below zero, investors will realize capital gains equal to the amount below zero. Investors should not confuse a fund's distribution rate with its performance, rate of return or yield.
