The Fund will invest primarily in common share and debt obligations anywhere in the world other than Canada.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

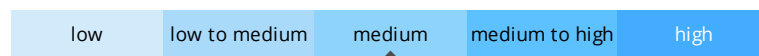

### Risk rating

Starlight Capital has rated the volatility of this fund as **medium**.

This rating considers how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

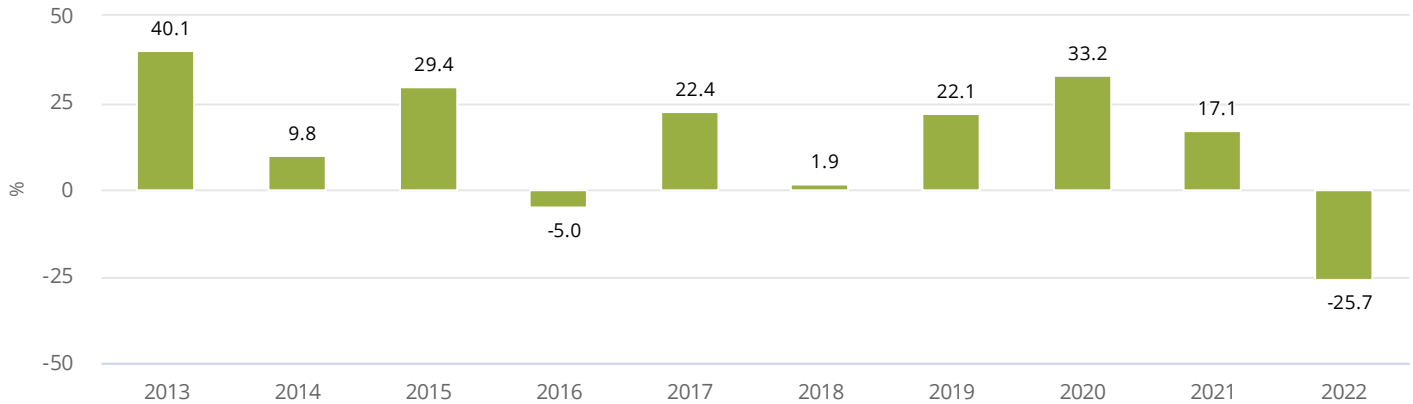
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the money you invest.

**How has the fund performed?**

This section tells you how Series F securities of the Fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

**Year-by-year returns**

The bar chart shows how the Series of the fund performed in each of the past 10 years. The fund's Series value has decreased in 2 of the past 10 years. The range of returns and change from year to year can help you assess how risky the Series of the fund has been in the past. It does not tell you how the Series of the fund will perform in the future.



**Best and worst 3-month returns**

This table shows the best and worst returns for Series F securities of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**Average return**

A person who invested \$1,000 in the Series of the Fund 10 years ago, your investment would now be worth \$3,235 as of May 31, 2023. This works out to an annual compound return of 12.5%.

**Who is this fund for?**

**This fund is suitable for investors:**

- Seeking capital growth and exposure to global securities
- With a mid-term to long-term investment horizon with a medium risk tolerance

This fund may not be suitable for investors with a short-term investment horizon.

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

The following tables show the fees and expenses you could pay to buy, own and sell Series F securities of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

[1. Sales charges](#)

No sales charge is paid when you own Series F of the Fund.

## 2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the fund. As of May 31, 2023, the fund's expenses were 1.47% of its value. This equals \$14.70 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the management fee (including the trailing commission) and operating expenses.	1.42%

Starlight Capital waived or absorbed some of the fund's expenses. If it had not done so, the MER for the fund would have been higher. The fund may pay the Manager a performance fee equal to 10 percent of the amount by which the series of the fund's rate of return exceeds that of its benchmark subject to a maximum of 0.30 percent of the fund's average net asset value. The benchmark for the Fund is the Morningstar® Developed Markets Large-Mid Cap Index.

### More about the trailing commission

Trailing commissions are not paid for Series F securities.

## 3. Other Fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	If you sell or switch securities within 30 days of purchase, you could pay a fee of 1.00% of the value of the securities you sell or switch. If we detect a pattern of excessive short-term trading, you could pay a fee of up to 2.00% of the value of securities you purchase, sell or switch within a 90-day period. This fee goes to the Fund.
<b>Switch or change fee</b>	Your representative's firm may charge you up to 2.00% of the value of securities you switch to another mutual fund managed by Starlight Capital. There is no fee payable to Starlight Capital for any switches of securities.
<b>NSF cheque fee</b>	We will charge you \$30 if a payment for a purchase of units is returned by your bank for any reason.
<b>Fee-based account fee</b>	Generally, you must participate in an eligible fee-based or wrap program with your representative's firm to purchase this series. Your representative's firm may charge you a fee, which is negotiated between you and your representative's firm and paid directly to them.

### What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
